*Gift Aid is a UK government scheme that enables charities to claim tax relief on donations from individual taxpayers. For every £1 a UK taxpayer donates, Eton can reclaim a further 25p. Additionally, higher-rate and additional-rate tax payers can claim back the difference between basic rate tax and the higher rate of 40% or 45% on the gross value of their gift through Self-Assessment.*
